





  - No issues

- External Hosting
  - FTP (gold standard)

## 2016/17/18 Changes . . .

- Internal Systems
  - Started being scrutinized after we started implementation of eXplorance
- External Hosting
  - More awareness is needed in all departments in PSI
  - IT needs to be involved (no rogue systems allowed)
  - Canada only (UK & Australia with individual consent)
  - PIA
  - FTP

#### 2019 into the Future? . . .

- Internal Systems
  - More and more are requiring the same scrutiny as external systems
- External Hosting
  - All schools and departments will be using externally hosted services
  - PIAs required for all
  - Better resourced to address privacy
  - Canada, UK, Europe, Australia, and ?



## Encryption . . .




- Transferring data
- Encrypted
  - All data is encrypted during transmission. (data sync)
  - Data is transformed to a randomly, encrypted string when CRN survey is opened
  - Encryption is deleted once survey closes
  - Student ID and data is encrypted as a unique identifier when URL is sent to student

- Firewalls, security, privacy, measures in place

#### Post-Secondary Institutions in Canada . . .

- Categorized under "Public Bodies"
- Non-exhaustive list of personal information examples:
  - Name, address, email address, or telephone number;
  - Age, sex, religious beliefs, sexual orientation, marital or family status, blood type;
  - An identifying number, symbol or other particular assigned to an individual;
  - Information about an individual's health care history, including a physical or mental disability;
  - Information about an individual's educational, financial, criminal or employment history; and
  - Personal views or opinions
- Regulations in place for each province

  - What, who, where, when, why, how
- 2. Scope of the PIA?
  - Clarity and focus
- 3. Any previous PIAs?
- 4. Elements of data?

- 7. Common or integrated program or activity?
- 8. Flow diagram or flow table
- 9. Risk mitigation?
- **10. Notifications**

## Example of Privacy Notification . . .

#### **Privacy Notice**

BCIT collects personal information provided by you through the employment process and through the the Student "Opinion of Instructional Quality Survey" (SOIQS) and "student evaluation of teaching" (SET) and development system under the Authority of section 26 of the *Freedom of Information and Protection of Privacy Act* RSBC. 1996, c.165 and the *College and Institute Act*, RSBC. 1996, c.52.

Your personal information is collected and used by the Learning and Teaching Centre pursuant to Article 13.2 of the <u>BCIT Faculty and Staff Association Collective Agreement</u> (the "FSA Collective Agreement"). To administer the web-based Student "Opinion of Instructional Quality Survey" (SOIQS) "student evaluation of teaching" (SET) and development system quality, BCIT discloses your personal information to eXplorance, an international learning experience management solutions provider headquartered in Montreal, PQ, Canada that provides similar services to post-secondary institutions in the Canada, USA, and throughout the world.

eXplorance collects instructors' SOIQS course survey requirements and uses this information to prepare and administer the web-based SOIQS survey, collect the survey responses, tabulate and analyze the responses to provide BCIT with aggregated survey results and summary reports.
