



# SOD/OHSU Program Response Rates
















AY 19-20 AY 20-21 **20.57%** vs **50.16% 10.72%** vs **45.56%**

### COURSE & INSTRUCTOR EVALUATION

The faculty members of the School of Dentistry continually seek to improve the quality of its instructional program to enhance student learning. The School of Dentistry evaluates instruction through course evaluations and faculty evaluations as part of the Curriculum Management Plan. Students are expected to evaluate courses and faculty each term. Completion of these evaluations is voluntary, however as part of your professional commitment to the program we strongly encourage you to participate.

### Why your feedback is important:

- The Commission on Dental Accreditation requires that each dental education program maintain a curriculum management plan. Every seven years an extensive site visit and document review are conducted for the college to maintain an accredited status.
- Course instructors use evaluation information to make improvements.

### What Does That Look Like?

### LETTERS OF COMMENDATION REQUIREMENTS

#### Minimum LOC Requirements for ALL SOD Courses

Students who must remediate any assessment are excluded from LOC eligibility.

Students must earn >92% on all written assessments.

Students must complete the OHSU BLUE Course Evaluation

#### What is Blue?

Blue is the approved course evaluation system built by Explorance, for summative student evaluations of course and instructional effectiveness. All OHSU Courses and instructors in all schools and programs are evaluated using Blue.

OHSU employs the use of summative Course Evaluation and Instructional Effectiveness Evaluations to assist faculty in monitoring the quality and effectiveness of teaching and support schools and departments in monitoring the quality of the curricula.

#### Summative Course Evaluation

OHSU requires students to engage in summative course evaluation as a component of every course, every term, using the OHSU evaluation system and questionnaire.

#### Instructional Effectiveness Evaluations

Student evaluation of instruction supports faculty in monitoring their instructional effectiveness, in decisions about tenure and promotion, identifies exceptional faculty for teaching awards, and may encourage innovative teaching and learning methodologies. Instructional Effectiveness Evaluations are strongly encouraged for all faculty and may be required by Academic Unit Heads and/or the school or college.





Course Term Blue Eval Response Rate Impact On Course




